For the same consideration, Assignor by these presence does sell, assign and transfer to **Atlanta Attachment Company** the full, exclusive and entire right, title and interest in and to any Canadian patent application or applications corresponding to said U.S. application, in whole or in part, in Canada, in and to any Patents and similar protective rights granted on said application or applications, and in and to the right to claim any applicable priority rights arising

from or required for said Canadian application or applications under the terms of any applicable conventions, treaties, statutes, or regulations; said Canadian applications to be filed and issued in the name of **Atlanta Attachment Company** and or its respective designees, insofar as permitted by applicable law;

AND, for the same consideration, Assignor does hereby agree to sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and other applications, make all assignments and rightful oaths, and generally do everything possible to aid **Atlanta Attachment Company** its successors, assigns, and nominees, to obtain and enforce proper protection for all said inventions and improvements in all countries throughout the world.
