Agreement with regard to Patent 7,075,008






This agreement can be changed by a written agreement of all four parties.

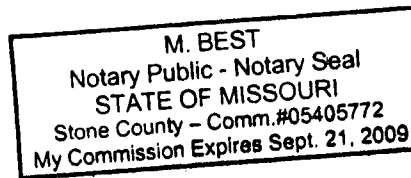

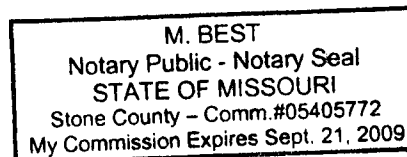

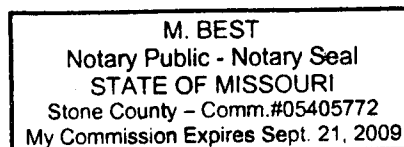
