AND ASSIGNOR HEREBY authorizes and request any official of any State whose duty consists of issuing patents, or other evidence or forms of any industrial property protection on any aforesaid application, to issue same to ASSIGNEE, its successors and assigns, in accordance herewith;

AND, WITHOUT LIMITING THE FOREGOING, ASSIGNOR hereby grants, conveys, sells, assigns, transfers, and delivers to ASSIGNEE all of the following rights and property with regard to said invention: (a) any and all claims for damages by way of past, present, and future infringement, if any, of any of the rights described herein, with the right to sue for and collect such damages for said use or infringement of the intellectual property rights identified herein; (b) all licenses or other rights, if any, to use any inventions or patents, including all license fees and royalties arising from such use to the extent permitted by license rights; and (c) all proceeds of the foregoing, including, without limitation, all payments under insurance or any indemnity or warranty payable with respect to any of the foregoing;

AND ASSIGNOR HEREBY covenants and agrees with ASSIGNEE, its successors and assigns, that ASSOGNOR has the full right to convey the entire interest assigned herein, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith, and that

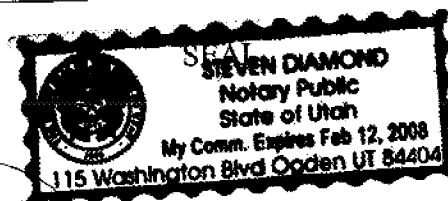
