BAUERMEISTER TO MEDCONFORM AG  
PATENT ASSIGNMENT

WHEREAS, WOLFGANG BAUERMEISTER, an individual citizen of Germany residing at Unnützstraße 17A, D-81825 München, Germany is the inventor and owner of the inventions and patents relevant thereto identified in the attached Appendix A, which shall collectively herein after be called the "Patent Properties";

WHEREAS, said BAUERMEISTER (hereinafter "Assignor") has desired to assign the entirety of its right and interest to said Patent Properties and any continuations, divisions, reissues, certificates of re-examination, extensions thereof, and corresponding ownership rights, worldwide, to MEDCONFORM AG, a corporation organized under the laws of Switzerland, and having a place of business at Nähseydi 1, Post, 6374 Buochs, Switzerland (hereinafter "Assignee").

Now, To All Whom It May Concern: Be it known that for and in consideration of good and valuable considerations transferred to said Assignor, the receipt of which is hereby acknowledged, the said Assignor has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over, unto the said Assignee its successor and assigns, the entirety of Assignor's heretofore undivided rights, title and interest, worldwide, in and to said Patent Properties, and any divisions, continuations, reissues, re-examination certificates or extensions thereof; the same to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by said Assignor had this assignment and sale not been made, together with all claims for damages by reason of past infringement of said Patent Properties with the right to sue for, and collect the same for Assignee's use and for the use of its successors, assigns and other legal representatives.

The Assignor agrees to execute all papers necessary in connection with said Patent Properties and any continuing, divisional or reissue applications or re-examinations thereof, and to execute separate assignments in connection with any of the Patent Properties should the Assignee deem same necessary or reasonably expedient.

The Assignor further agrees to execute all papers reasonably necessary in connection with any proceeding which may be declared concerning any of said Patent Properties and to cooperate with Assignee in all reasonable ways in obtaining evidence and going forward with any such proceeding.

The Assignor further agrees to execute all papers and documents and perform any act which may be reasonably necessary in connection with claims or provisions of any international convention or similar agreement affecting any of said Patent Properties.

The Assignor hereby represents and warrants that it has the full right to convey the interest herein assigned, and that it has not executed and will not execute, any agreement in conflict herewith.

The Assignor grants the firm of Steptoe & Johnson LLP the power to insert on this Assignment any further identification which maybe necessary or desirable to comply with the rules of the U.S. Patent and Trademark Office for recording of this document.
