
ASSIGNMENT


This Assignment is made the 2<sup>nd</sup> day of May 2006, as a date of contract exchange between:

It is also hereby agreed that the Assignor will, at the expense of the Assignee, execute all such documents, and do all such things, as may reasonably be required for the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned, including (if required to do so by the Assignee) applying for patents in the name of the Assignor.
