ASSIGNMENT OF PATENT APPLICATION

WHEREAS, I, DR. SOPHIA BETHANI (hereinafter referred to as "ASSIGNOR"), a citizen of GREECE, have invented PYROPROCESSED AGGREGATES COMPRISING IBA AND PFA AND METHODS FOR MAKING SUCH AGGREGATES, for which an application for Letters Patent of the United States of America was filed on September 28, 2005, and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over unto the said ASSIGNEE, its successors and assigns, the full and exclusive right, title and interest in, to and under said invention, said application and all Letters Patent or similar legal protection, not only in the United States of America and its territorial possessions, but in all countries foreign thereto, to be obtained for said invention by said applications, and to any continuation, division, renewal, substitute or reissue thereof or any legal equivalent thereof in the United States of America or a foreign country for the full term or terms for which the same may be granted, including all priority rights under the International Convention; and ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Letters Patent or any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.




ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;
