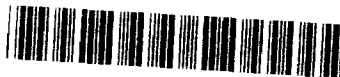

said invention and all applications for patents on said invention in said Assignee, successors, assigns, or legal representatives;




