AMENDED AND RESTATED CERTIFICATE OF FORMATION
OF
CENTEON L.L.C.

This Amended and Restated Certificate of Formation of Centeon L.L.C. (the "LLC"), dated December 21, 1999, has been duly executed and is being filed by John Bond, as an authorized person, in accordance with the provisions of 6 Del. C. § 18-208. This Amended and Restated Certificate of Formation is to be effective on January 1, 2000. The LLC was originally formed under the name Verion L.L.C., pursuant to a Certificate of Formation filed on May 15, 1995 with the Secretary of State of the State of Delaware (the "Certificate"). The Certificate of Formation was amended by that certain Certificate of Amendment of Verion L.L.C. which was filed on July 13, 1995 with the Secretary of State of Delaware pursuant to which the LLC changed its name from Verion L.L.C. to Centeon L.L.C.

The Certificate is hereby amended and restated in its entirety to read as follows:

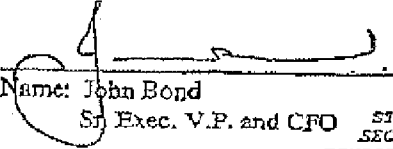
