ASSIGNMENT

WHEREAS, Reginald James Davis, a citizen of the United States and a resident of Cockeysville, MD, Kevin Kaufman, a citizen of the United States and a resident of Fort Worth, TX, Greg Hoffman, a citizen of the United States and a resident of Fort Wayne, IN, Alan McGee, a citizen of the United States and a resident of Fort Wayne, IN, Jean Huppert, a citizen of France and a resident of L'etrat, France, Hugues Mousselard, a citizen of the France and a resident of Paris, France, and Ludovic Rillardon, a citizen of France and a resident of Le Raincy, France (hereinafter called the "Assignors") have invented a certain new and useful invention entitled "**Transforanimal intersomatic cage for an intervertebral fusion graft and an instrument for implanting the cage**" (the "Invention") for which an application for a United States Patent was filed on March 17, 2006, Ser. 3. All rights of action on account of past, present and future misappropriation or unauthorized use of said Invention in any form, including but not limited to any infringement of any patent that may issue from the Application or from any other patent applications directed to said invention, any other patents or like grants or protection on said Invention, and any trade secret misappropriation of said Invention;

4. The right to Assignee to file in its name applications for patents and like grants or protection for said Invention in the United States and in any country or countries foreign to the United States; and

5. All international rights or priority associated with said Invention, said Application, and any other applications for patents, patents and like grants or protection on said Invention.


