**CERTIFICATE OF AMENDMENT TO
AMENDED AND RESTATED ARTICLES OF INCORPORATION OF
EXPERCLICK, INC.**

The undersigned certifies that:

1. He is the duly elected and acting Chief Executive Officer and Secretary of Experclick, Inc., a California corporation (the "Company").

2. Article I of the Amended and Restated Articles of Incorporation of this corporation is amended and restated to read in full as follows:

"The name of this company is AdECN (the "*Company*" or the "*Corporation*")."

3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors of the Company.

4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The Company has two classes of stock and two series of Preferred Stock outstanding and such classes and series of stock are entitled to vote with respect to the amendment herein set forth. The total number of outstanding shares of Common Stock of the Company is 263,855. The total number of outstanding shares of Preferred Stock of the Company is 7,349,842. The total number of outstanding shares of Series A-2 Preferred Stock of the Company is 3,905,398. The total number of outstanding shares of Series A-1 Preferred Stock of the Company is 3,444,444. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was (i) more than fifty percent (50%) of the Series A-1 Preferred Stock and Series A-2 Preferred Stock voting together as a single class and (ii) more than fifty percent (50%) of the outstanding Common Stock and Preferred Stock voting together as a single class.

I further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of my own knowledge.
