ASSIGNMENT



AND ASSIGNORS hereby agree, without requiring further remuneration, to execute any papers requested by ASSIGNEE, its successors, assigns and legal representatives, deemed essential by ASSIGNEE to ASSIGNEE's full protection and title in and to the intellectual property rights hereby transferred,

AND ASSIGNORS hereby covenant that ASSIGNORS have full right to convey the entire interest herein assigned, and have not executed, and will not execute, any agreement in conflict herewith.


