

I hereby authorize Thomas Picciolo to file patent applications in any or all countries on any or all of said invention in my name or in the name of Thomas Picciolo or otherwise as Thomas Picciolo may deem advisable under any International Convention or otherwise.


I hereby authorize the Commissioner of Patents of the United States and the empowered officials of all other governments to issue or transfer all said Letters Patent to Thomas Picciolo, as assignee of the entire right, title and interest therein or otherwise as I may direct, in accordance with this instrument of assignment.

I hereby represent that there are no rights or interests inconsistent with the rights and interests granted herein and that I will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and I hereby bind myself and my heirs, executors, administrators, and legal representatives, as the case may be, to execute and deliver to Thomas Picciolo, his successors and assigns, any further documents or instruments and do any and all further acts that may reasonably be deemed necessary by Thomas Picciolo to enable Thomas Picciolo, his successors and assigns, to file applications for the invention in any country where it may elect to file such applications, and that may be necessary to vest in Thomas Picciolo, his successors and assigns, the title herein conveyed or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.
