**INTELLECTUAL PROPERTY
ASSIGNMENT AGREEMENT**

THIS ASSIGNMENT is effective as of June 22, 2006 (the "Effective Date") from ELECTRONIC BILLBOARD TECHNOLOGY, INC., a Delaware corporation (the "Assignor"), to NOVUS COMMUNICATION TECHNOLOGIES, INC., an Ohio corporation (the "Assignee").

WHEREAS, the Assignee has purchased substantially all of the system or method patents related to the digital billboard networks or advertising industry of the Assignor pursuant to that certain Patent Purchase Agreement dated of even date herewith by and among the Assignor, the Assignee and Nano-Proprietary, Inc. (the "Agreement");

WHEREAS, the Assignor is the owner of certain intellectual property rights; and

WHEREAS, the Assignee is desirous of acquiring the entire right, title and interest in and to said intellectual property rights in accordance with the terms of the Agreement.

NOW, THEREFORE for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby agrees as follows:

1. **System and Method Patents.** As of the Effective Date, the Assignor does hereby irrevocably sell, assign, and transfer to the Assignee, its successors and assigns, the Assignor's entire right, title and interest in and to all system and method patents or patent applications (and all patents issuing therefrom) further described in Exhibit A, owned or licensed by the Assignor, related to digital billboard networks and advertising therewith, and all goodwill associated therewith, and all continuations, continuations-in-part, divisionals, reexaminations, reissues, extensions, and foreign counterparts, as well as all patents or patent applications claiming priority from any of the foregoing, and the right to claim priority to any of the foregoing.

2. **Other Intellectual Property Rights.** As of the Effective Date, the Assignor does hereby irrevocably sell, assign, and transfer to the Assignee, its successors and assigns, Assignor's entire right, title and interest in and to any and all documents and documentation (whether in written or electronic form), owned, possessed, in the custody of or under the control of the Assignor, which are related to the Intellectual Property, including, but not limited to research documentation, inventors' notebooks, prototypes, designs, software and similar materials, invention disclosure documents, and file histories for any patents and patent applications, the right to all causes of action (either in law or equity) and the right to sue, counterclaim, cross-claim, and recover for past, present or future infringement, misappropriation or violation of the Intellectual Property (or any portion thereof) in the United States and throughout the world.

3. **Further Acts.** The Assignor agrees to execute all papers and to perform such other proper acts as Assignee may deem necessary to secure to the Assignee or to its designee the copyright, trademark, patent, trade secret and other intellectual property rights herein assigned.

4. **Miscellaneous.**

a. Headings. The headings in this Assignment are for convenience of reference only and shall not limit or otherwise affect any of the terms or provisions hereof.

b. Governing Law. This Assignment and the rights and obligations of the parties hereto shall be governed by and construed and enforced in accordance with the laws of the State of Ohio.

c. Assignability. This Assignment will inure to the benefit of and be binding upon the parties hereto and their respective successors, assigns, estates, heirs and legal representatives.

d. Capitalized Terms. Capitalized terms not otherwise defined herein shall have the same meaning as in the Agreement.

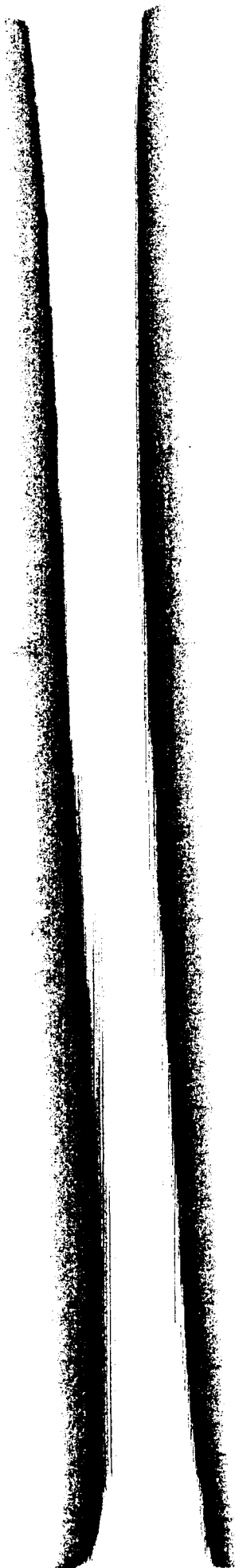
