## ASSIGNMENT

ASSIGNMENT made this 4<sup>th</sup> day of January, 1999, by KIM MACI PURINGTON, JEFFREY DOUGLAS POWERS and ROBERT JAMES WRIGHT, herein referred to as Investors, hereinafter sometimes referred to as "Assignors", and PDS POWER DELIVERY SYSTEMS INC., a corporation organized and existing under the laws of the State of Hawaii, whose business and post office address is 245 Keaniani Place, Kailua, Hawaii 96734, hereinafter referred to as "Assignee";

WHEREAS, Investors have obtained letters patent of the United States of America for certain new and useful improvements concerning a swiveling electrical connector, which letters patent are numbered 5,803,750 and bear the date of September 8, 1998; and

WHEREAS, Investors are the sole and exclusive owners of the letters patent and the invention described therein and all rights in the same; and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in the letter patent and invention.

### NOW THEREFORE,

In consideration of the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt of which is acknowledged, the parties agree as follows:

1. **ASSIGNMENT.** Investors assign to Assignee the inventions and the letters patent and any reissues of the letters patent, the same to be held and enjoyed by Assignee for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives to the end of the term or terms for which the letters patent are granted or reissued, as fully and entirely as the same would have been held and enjoyed by Inventors if this assignment had not been made, together with all claims for damages by reason of past infringement of the letters patent with the right to sue for and collect the same for its own use, and for the use of its successors, assigns, or other legal representatives.

2. **AUTHORIZATION AND REQUEST.** Investors authorize and request the Commissioner of Patents and Trademarks to issue any and all letters patent of the United States on the invention, or any division or divisions thereof to Assignee of the interest herein assigned.

3. **COVENANT.** Investors covenant that they have full right to convey the interest herein assigned and that they or any of them have not executed and will not execute any agreement in conflict herewith.

4. **COOPERATION.** Investors and each of them, covenant and agree that they will at any time on request execute and deliver any and all papers that may be necessary or desirable to perfect the title to the invention or any letters patent that are granted therefor. Investors and each of them further covenant and agree that they will at any time on request communicate to Assignee any facts relating to the invention and letters patent or the history thereof and testify as to the same in any interference or other litigation when requested to do so.
