ASSIGNOR warrants, covenants and represents the fact that it has the right to sell, assign, transfer and convey the rights, titles and interests hereby assigned.





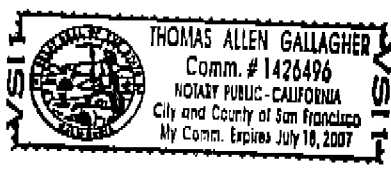
