LEGAL MORTGAGE

THIS LEGAL CHARGE IS MADE THIS 8th DAY OF JULY 2005

BETWEEN:

(1) **NPF Limited** of Unit 10 Metro Triangle, 221 Mount Street, Nechells, Birmingham, West Midlands B7 5QT, company number 03150189 ('the Company')

and

(2) **Jonathan Charles Green** of 25 Birchfield Avenue, Tettenhall, Wolverhampton, West Midlands WV6 8TE
Gerard Green of Keepers Cottage, Brockhurst Lane, Canwell, Sutton Coldfield B75 5SN
Matthew Gordon Green of 25 Birchfield Avenue, Tettenhall, Wolverhampton, West Midlands WV6 8TE ('the Lenders')

1. Receipts

In consideration of the Lenders' providing a loan and agreeing to provide further advances to the Company, the Company undertakes to and agree with the Lenders as set out below.

2. Repayment

The Company shall repay to the Lenders on demand all monies for which the Company may at any time after this date be indebted or liable to the Lenders together with interest at the rate of 1% per annum over the base rate of Bank of Scotland from time to time (the aggregate of such monies and interest being 'the Indebtedness').

3. Mortgage

The Company as beneficial owner hereby assigns to the Lenders as security for the Indebtedness the intellectual property rights set out in the schedule attached hereto along with any intellectual property rights which the Company may acquire in the future (collectively 'the IP Rights').

4. Reconveyance

If the Company pays the Indebtedness to the Lenders in full the Lenders shall at the request and cost of the Company re-assign the IP Rights to the Company on request.

5. Lenders' powers

If the Indebtedness is not repaid to the Lenders on demand the Lenders may at any time without giving any notice to the Company sell or deal in any other way with the IP Rights or any of them and apply the proceeds of sale:

- first in payment of the costs of sale;
- secondly in the payment of any costs incurred in connection with the mortgage by the Companies of the IP Rights;

- thirdly in the payment of interest on the principal sums or the balance of them for the time being remaining unpaid down to the date of sale;
- fourthly in the repayment of the principal sums or the balance of them remaining unpaid;
- and finally in payment of any balance to the Company.

6. Exercise of Lenders' powers

The Lenders or their survivors shall act unanimously in exercising any of their rights under this charge.


7. Interpretation


In this charge, unless the context requires otherwise, the singular includes the plural and vice versa and references to persons include references to companies.


8. Governing law and jurisdiction


This agreement shall be construed and governed in accordance with English law and the Courts of England are to have jurisdiction to settle any dispute which may arise in connection with this agreement.
