international convention, treaty, or agreement that is or may be predicated upon or arise from said invention, application and other applications or letters patent therefor, all to be held and enjoyed by Aquaice, LLC, its successors and assigns, all the same as I would have held and enjoyed had this Assignment not been made;

I authorize and grant the right to Aquaice, LLC to file and prosecute patent applications in all countries for any part of said invention in my name or in the name of Aquaice, LLC or otherwise, as Aquaice, LLC may deem advisable under any international convention, treaty, or agreement or otherwise;



I represent and warrant that there are no rights or interests outstanding inconsistent with the rights and interests granted herein; I covenant that I will not execute, grant, or transfer any rights or interests inconsistent herewith; I bind myself to execute and deliver to Aquaice, LLC, its successors and assigns, any further documents or instruments and to perform any further lawful acts that may reasonably be deemed necessary to enable it, its successors and assigns, to file the said applications for letters patent for the said invention in any country in which it may elect to file such applications, and to vest in Aquaice, LLC, its successors and assigns, the title herein conveyed and intended to so be conveyed, and to enable such title to be recorded in the United States and each foreign country in which each such application may be filed so that any



patent issued thereon shall be issued to Aquaice, LLC, its successors and assigns; and I further covenant and agree, that I will, upon request, communicate to Aquaice, LLC, its successors and assigns, any facts relating to the said invention and the history thereof known to me, and that I will testify as to the same in any interference or other litigation when requested to do so by Aquaice, LLC, its successors and assigns.
