**INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION**

WHEREAS, XtremeSpectrum, Inc., a Delaware corporation, whose address is 8133 Leesburg Pike, Suite 700, Vienna, Virginia 22182 (the "Company"), and Silicon Valley Bank, a California chartered bank, whose address is 3003 Tasman Drive, Santa Clara, California 95054 ("Bank"), entered into a certain Intellectual Property Security Agreement (the "Agreement"), dated as of February 28, 2003, which was recorded in the United States Patent and Trademark Office on February 28, 2003 at Reel 013447 and Frame 0475 for published patents, recorded on February 28, 2003 at Reel 013452 and Frame 0597 for unpublished patents and recorded on February 28, 2003 at Reel 002611 and Frame 0845 for trademarks, that by its terms granted Bank a security interest in certain intellectual property listed in Exhibit B (the "Patents"), Exhibit C (the "Trademarks") and all trademark applications, trademark registrations, pending patents and patents acquired or arising after the date of the Agreement; and

WHEREAS, the Company has or has caused to be paid and satisfied in full the obligations for which the security interest in the Intellectual Property was granted.

NOW THEREFORE the parties hereto agree that Bank hereby reassigns to the Company the interest in the Patents and Trademarks in which Bank was granted a security interest under the Intellectual Property Security Agreement. The Bank also hereby releases its security interest in the Patents and Trademarks. The Bank, further agrees at the Company's expense for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Company, to effectuate this termination.

IN WITNESS WHEREOF the parties hereto by the signature below of its duly authorized representatives agree to be bound by the provisions of this Intellectual Property Termination Agreement as of the date of execution, this 20 day of November, 2003.
