ASSIGNOR further agrees to execute such additional instruments as may be necessary or desirable to confirm the transfer of rights as herein contemplated and to permit said Assignee its successors, legal representatives and assigns to obtain and enforce patent protection on said inventions in all countries.

IN WITNESS WHEREOF, ASSIGNOR has caused this instrument to be executed by its duly authorized corporate officer effective this 5th day of December, 2006.

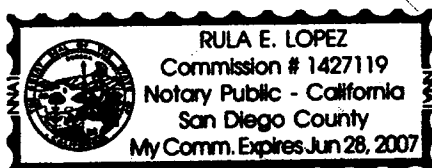
