ASSIGNMENT

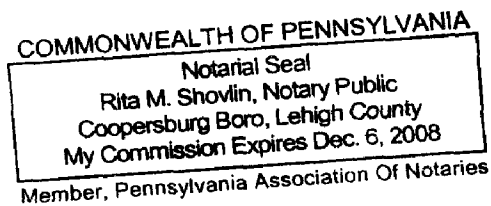
