ASSIGNMENT

We, Lap-Keung Lee and Lawrence M. Abrams, of 12 East Kincaid Drive, West Windsor, New Jersey 08550, and 1254 Sequoia Road, Cherry Hill, New Jersey 08003, respectively, have invented an invention entitled EBULLATED BED REACTOR SYSTEM AND METHOD FOR HYDROPROCESSING WAX FROM FISCHER-TROPSCH REACTION hereinafter called the "invention."
