



### Assignment of Patent Rights

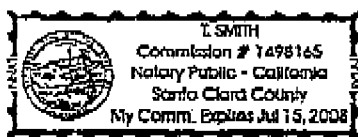
