WHEREAS, Assignee wishes to acquire from Assignor, and Assignor wishes to transfer to Assignee, all right, title and interest in, to and under the Patents;

NOW, THEREFORE, for good and valuable consideration, including a cash payment of \$5,000 delivered herewith, the receipt and sufficiency of which is hereby acknowledged by Assignor:

1. Assignor hereby conveys, assigns, quitclaims, transfers and delivers to Assignee, its successors and assigns, all right, title and interest throughout the world in, to and under the Patents, and the underlying inventions described therein and any United States or foreign reissues, divisions, renewals, extensions, provisionals, continuations and continuations-in-part thereof, and substitutes therefor, and all letters patent of the United States which have been or may be granted thereon and all foreign counterparts thereof, together with the right to sue and recover damages for future or past infringements of the Patents and to fully and entirely stand in the place of Assignor in all matters related thereto. The Patents purchased hereby are free and clear of any liens, claims, encumbrances, or interests pursuant to 11 U.S.C. 363, including any third party liability claims that may relate to or arise from the Patents,
2. Assignor confirms with its signature below that it has received an order of the Bankruptcy Court authorizing the sale and assignment to Assignee pursuant to the terms hereof after necessary notice to creditors and other parties-in-interest of Vectrad. The final form of order is attached hereto as Exhibit A.
3. Assignor agrees to take such further reasonable action requested by Assignee to carry out and fulfill the purposes and intent of this Patent Assignment; provided that these actions do not burden Assignor with any expense.
4. Assignor hereby requests the Commissioner of Patents and Trademarks (the "Commissioner") to record this Patent Assignment to Assignee. Assignor hereby further requests the Commissioner to issue any and all letters patent of the United States resulting from applications on any Patents or derived from the Patents to Assignee as assignee of the entire interest. Assignor hereby warrants and covenants that, subject to Bankruptcy Court approval, it has full right to convey the entire interest herein assigned, and further that Assignor will not execute any agreements inconsistent herewith.

Subject to the foregoing, the assignment of the Patents pursuant to this Patent Assignment is "as is where is" without warranty of any kind. The document may be executed in one or more counterparts, each of which shall be deemed an original, and such counterparts shall together constitute one and the same agreement, binding upon the parties hereto.

ADDENDUM TO PATENT ASSIGNMENT

This Addendum to Patent Assignment dated as of February 10, 2005 between Vectrad Networks Corporation, a Washington corporation ("Assignor") and Adaptix, Inc., a Delaware corporation ("Assignee"), is attached to and hereby made a part of that certain Patent Assignment dated as of December 17, 2004 between Assignor and Assignee.

RECITAL

- A. Assignor and Assignee intended that the Patent Assignment assign to Assignee the entire patent-related intellectual property portfolio held by Assignor, which the parties thought they had listed with Schedule 1 attached thereto. Patent counsel has subsequently noted to the parties that the original Schedule 1 lists all issued patents and pending applications, but that these properties do not make up the entire patent-related intellectual property portfolio. In fact, that portfolio also includes certain patent applications that have been abandoned, and certain disclosures made to Assignor and/or Assignor's counsel by Assignor Personnel that constituted Assignor's inventions, identified in the attached Annex A.
 - B. The parties determined to execute this Addendum to add Annex A to Schedule 1, as part of their "further assurances" agreement to execute additional documents to clarify the effect of, and perfect, the transfer of Assignor's patent-related intellectual property portfolio to Assignee.
1. Assignor and Assignee agree that the attached Annex A is, by this reference, incorporated into and made a part of Schedule 1 of the Patent Assignment, such that title to the assets on Annex A transferred to Assignee under the Patent Assignment with the same effect as the assets listed on Schedule 1. This Addendum simply clarifies the scope of the conveyance under the Patent Assignment, supported by the consideration named therein, and requires no additional consideration.
 2. Except as specifically supplemented and amended hereby, the Patent Assignment shall remain in full force and effect and is hereby ratified and confirmed in all respects. This Addendum may be executed in one or more counterparts, each of which shall be deemed an original, and such counterparts shall constitute a single instrument, binding on Assignor and Assignee. This Addendum shall be governed by and construed in accordance with the laws of the State of Washington.



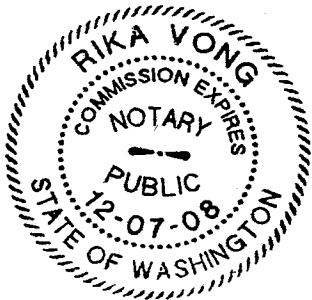


