

Assignment before issue of Letters Patent

WHEREAS, **Philippe Noelle**, resident of Vinceny France, and **Robert Mavir**, resident of Bolton, UK (hereinafter "Assignors") have invented certain new and useful improvements in

EGR MIXER AND PORTED SHROUD COMPRESSOR HOUSING

(hereinafter "invention") for which Assignors are making or have made application for Letters Patent of The United States, Which Application has been duly executed by Assignors on even date herewith;

NOW, THIS INDENTURE WITNESSETH, that for good and valuable considerations, the receipt whereof is hereby acknowledged, Assignors have assigned, sold and transferred, and do hereby assign, sell and transfer to the said Assignee the entire right, title and interest in and to the said invention, within the United States of America and its territorial possessions and all foreign countries and in and to any Letters Patent of the United States and foreign countries, including utility models, inventor's certificates and like government grants, and all divisions, reissues, continuations and extensions thereof that may be granted therefor, and the right to apply for Letters Patent in foreign countries with full benefit of such priorities as may now or hereafter be granted to Assignors by local laws or by treaty, including any international convention, for the protection of industrial property, together with the right to extend the protection of said U.S. Letters Patent to the various territorial possessions now owned or which may be hereafter acquired by the United States of America, all said rights to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors or assigns, to the full end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held and enjoyed by Assignors if this assignment and sale had not been made. And Assignors do hereby request and authorize the Commissioner of Patents and Trademarks, U.S.A., to issue said U.S. Letters Patent, when granted, in accordance with this assignment.

Assignors further covenant and agree with the Assignee that Assignors have a full and unencumbered title to the invention hereby assigned, which title Assignors warrant unto the Assignee, and Assignors further agree that Assignors will, without demanding any further consideration therefor, at the request but at the expense of the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining, sustaining, extending, reissuing or reexamining United States and foreign Letters Patent or the like for the said invention, and for maintaining and perfecting the Assignee's right to said invention, and for maintaining and perfecting the Assignee's right to said invention and Letters Patent particularly in cases of interference, conflict, opposition and litigation.
