And I do hereby authorize and request the Commissioner of Patents and Trademarks of the United States to issue any Letters Patent of the United States, resulting from said Patent Property when granted, to said Assignee.

The Assignor agrees to execute all papers necessary in connection with any further proceedings concerning said Patent Properties such as any interference or any continuation or any


reissue or any reexamination thereof, and to cooperate with said Assignee in every way possible in obtaining evidence and going forward with any such proceedings.


The Assignor hereby covenants that it has full right to convey the interest herein assigned and that it has not executed and will not execute any agreement in conflict herewith.
