ASSIGNMENT

WITNESSETH: That,

WHEREAS, we are the joint inventors of certain new and useful improvements in **ON-CHIP ESD PROTECTION CIRCUIT FOR RADIO FREQUENCY (RF) INTEGRATED CIRCUITS** for which we are about to make application for Letters Patent of the United States, and for which we have executed a declaration;

For the consideration aforesaid, we have sold, assigned, transferred and set over, and by


