

**ASSIGNMENT OF RIGHTS IN PATENTS  
AND PATENT APPLICATIONS**

This Assignment of Rights in patents and patent applications is entered into and made effective as of 10/23/ 2006 and is between ONDAL INDUSTRIETECHNIK GmbH, a German corporation having a principle place of business at: Wellastrasse 2-4, D-36085 Hünfeld, Germany ("Assignor) and STERIS, INC., a Delaware corporation having a principal place of business at: 43425 Business Park Drive, Temecula, California 92590 US ("Assignee").

WHEREAS, Assignor is the joint owner of the patents which were registered in, and the patent applications which were filed with, the United States Patent Office and further identified in Exhibit A attached hereto, which is made a part hereof; and,

WHEREAS, Assignor has agreed to transfer to the Assignee all of its right, title and interest in and to the patents and patent applications identified in Exhibit A; and,

inventions underlying the patents or patent applications, with the right to sue for and collect the same.

(2) Assignor does hereby also assign in the United States, any and all right, title, and interest in and to any and all copyright property appertaining to any drawings or other materials relating to the tangible means of expression and illustration of the patents and patent applications.

(3) Upon notice by the Assignee, Assignor does hereby covenant and agree to provide any such further information and documentation as may be necessary to record, in the United States, this Assignment and any and all other documents necessary to perfect the transfer of the patents and patent applications identified in Exhibit A.
