unencumbered and that Assignor has good and fill right and lawful authority to sell and convey the same in the manner herein set forth.

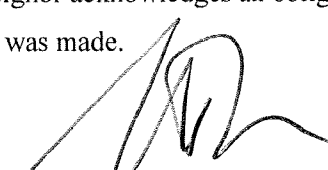
