## **ASSIGNMENT OF PATENT RIGHTS**

This ASSIGNMENT OF PATENT RIGHTS (this "Assignment"), is entered into by Oasis Semiconductor Inc., a Delaware corporation, 201 Jones Rd., Waltham, MA 02451 ("Assignor"), with and for the benefit of SigmaTel, Inc., a Delaware Corporation, 1601 S. Mopac, Austin, TX 78746 ("Assignee").

**WHEREAS**, Assignor has agreed to sell, assign, and transfer, and Assignee has agreed to acquire all of Assignor's rights, title and interests in and to pending U.S. Application No. 11/032,604, entitled "FLEXIBLE SDRAM CLOCKING (MS-DLL)," and filed on January 10, 2005, and including divisions, continuations, continuations-in-part, renewals, substitutes and extensions thereof, and in and to any and all resulting patents of every country or region that may be granted or have been granted, including any reissues and reexaminations thereof, (the "Assigned Patent Rights").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, and transfers to Assignee any and all worldwide rights, title and interests Assignor holds, or may hold, in and to the Assigned Patent Rights, together with all rights derived therefrom, including but not limited to the right to sue for and collect damages for past, present and future infringement.

Assignor further agrees that, should additional or further documentation of the assignment be required for whatever reason, Assignor will, without further consideration, provide or execute such other information or documents as may be useful or necessary upon Assignee's reasonable request.

Assignor hereby covenants that no assignment, sale, license, agreement, or encumbrance has been or will be made or entered into that would conflict with this Assignment.

This Assignment shall be binding on and shall inure the benefit of, the parties hereto and their respective successors and assigns. This Assignment will be governed by, and construed in accordance with, the internal laws of the State of Delaware applicable to contracts executed and performed entirely therein, without regard to the principles of choice of law or conflicts of law of any jurisdiction. If any term or other provision of this Assignment is invalid, illegal or incapable of being enforced by any rule of law or public policy, all other conditions and provisions of this Assignment will nevertheless remain in full force and effect so long as the economic or legal substance of the transaction contemplated hereby is not affected in any manner materially adverse to any party. Upon such determination that

any term or other provision is invalid, illegal or incapable of being enforced, the parties hereto will negotiate in good faith to modify this Assignment so as to effect the original intent of the parties as closely as possible in order that the transaction contemplated hereby is consummated as originally intended to the greatest extent possible.

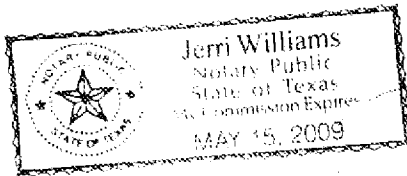
