ASSIGNMENT OF PATENTS

THIS ASSIGNMENT OF PATENTS is made as of the 2nd day of January, 2007, by UVP, Inc., a California corporation ("Assignor"), to UVP, LLC, a Delaware limited liability company ("Assignee").

ASSIGNMENT

NOW, THEREFORE, Assignor, for and in exchange for the payment of the purchase price set forth in the Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Patents and any reissue or reissues of such Patents that may be granted, all rights to sue for infringement of any Patent, whether arising prior to or subsequent to the date of this Assignment of Patents, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Patents not been made.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to issue any and all letters patents that may be granted upon any patent applications to Assignee, its successors and assigns.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Patents shall be governed by and construed in accordance with the laws of the State of California without giving effect to the principles of conflicts of laws thereof.
