
ASSIGNMENT

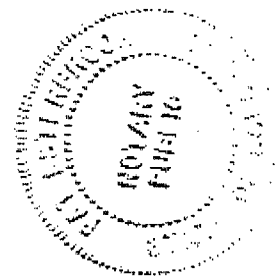

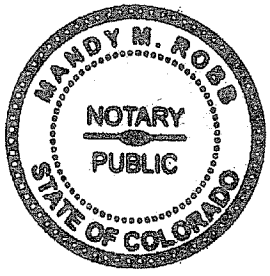

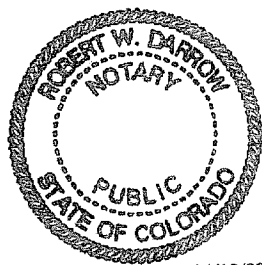
