ASSIGNMENT

WHEREAS, WE, Daigo Ishiyama, residing at 182 Evergreen Road, Apt. 14A, Edison, New Jersey 08837, Gary Uhl, residing at 10 Hillcrest Road, Fair Haven, New Jersey 07704 and Vince Rotella, residing at 55 Highfield Road, Colonia, New Jersey 07067, have invented certain new and useful improvements in a BATHTUB AND SHOWER ENCLOSURE for which we have executed an Application for Letters Patent of the United States on September 18, 2006 and identifies as U.S. Serial No. 29/266,262;

WHEREAS, American Standard International Inc., a Delaware corporation, having its principal place of business at 1370 Avenue of the Americas, New York, New York 10019, hereinafter referred to as ASSIGNEE, is desirous of obtaining the entire right, title and interest in, to and under the said improvements and the said application;


Letters Patent for said improvements to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;

AND WE HEREBY further covenant and agree that we will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
