ASSIGNMENT

WHEREAS, I, Takeshi HASHIMOTO, a citizen of Japan, residing at Toyota-shi, Aichi-ken, Japan, respectively, have invented new and useful improvements in CLAMP for which I am about to make application for Letters Patent of the United States, said application having been executed by me on even date herewith; and

And I hereby authorize and request the Commissioner of Patents to issue all such Letters Patent to the Assignee, its successors and assigns, in accordance with this instrument of Assignment.

I hereby represent and warrant that there are no rights and interests outstanding inconsistent with the rights and interests granted herein and that I will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and I bind myself, my heirs, executors, administrators and legal representatives, as the case may be, to execute and deliver to the Assignee, its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the Assignee, its successors and assigns, to vest in the Assignee, its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States.

And I further covenant and agree, in consideration of the premises that I, my executors and administrators, will at any time upon request communicate to the Assignee, its successors and assigns, any facts relating to the invention and improvements and the history thereof, known to me or my executors and administrators, and that I will testify as to the same in any interference or other litigation when requested so to do by the Assignee, its successors and assigns.
