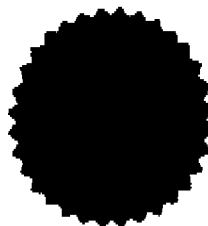

1. The name and states of incorporation of each of the constituent corporation and limited liability company that are to merge in the Merger (the "Constituent Entities"), are:

"Article I. Name. The name of the corporation is Siemens Communications, Inc."

5. The executed Merger Agreement is on file at the offices of the surviving corporation at Siemens Information and Communication Networks, Inc., 300 Broken Sound Parkway, Boca Raton, Florida 33287.

6. A copy of the Merger Agreement will be furnished by the surviving corporation, on request and without cost, to any stockholder or member of either of the Constituent Entity.
