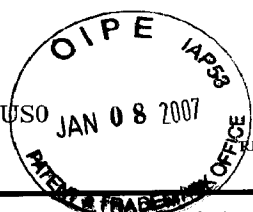

SPRING STEEL WITH EXCELLENT RESISTANCE TO HYDROGEN EMBRITTLEMENT AND STEEL WIRE AND SPRING OBTAINED FROM THE STEEL

for which an application for Letters Patent was executed on August 1, 2006 (Application No. 11/538,703, filed October 4, 2006), and
