ASSIGNMENT

Further, the Assignor and their legal representatives, heirs, and assigns do hereby agree and covenant without further remuneration that they will communicate to the Assignee, its successors, legal representatives and assigns, any facts known to them respecting the Patent Application whenever requested, and will testify in any interferences or other legal proceeding in which any of the Patent Application or Letters Patent may become involved, sign all lawful papers, execute and deliver all divisional, continuing, reissue and other applications based upon the Patent Application and all assignments thereof to the Assignee or its legal representatives, successors, or assigns, make all rightful oaths and generally do everything necessary to assist the Assignee, its successors, legal representatives and assigns, to obtain and enforce all rights related to the Patent Applications in the U.S. and the countries, the expenses incident thereto to be borne and paid by the Assignee.
