WHEREAS, we, Michael E. Spencer (resident of Escondido, California, whose postal mailing address is 306 West El Norte Parkway, Suite N #409, Escondido, California 92026), and James J. Croft III (resident of Poway, California, whose postal mailing address is 13633 Quiet Hills Drive, Poway, California 92064), and Joseph O.
