ASSIGNMENT AND AGREEMENT

WHEREAS we, Michael S. Butler of 6N343 Mission Hills Drive, St. Charles, Illinois 60175, and Michael J. Milella, Jr. of 257 Sheffield Drive, Schaumburg, Illinois 60194 (and hereinafter referred to as "Inventors"), do hereby execute this Assignment and Agreement.

We Inventors hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right of Life Spine to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.

We Inventors request that any and all patents for said inventions be issued to Life Spine in the United States and in all countries foreign to the United States, or to such nominees as Life Spine may designate.
