ASSIGNMENT

I, Josef Bille, of Hermann Loens Weg, 44/1, 69118 Heidelberg, Germany, have invented a method and apparatus entitled ADAPTIVE OPTICS FOR COMPENSATING FOR OPTICAL ABERRATIONS IN AN IMAGING PROCESS, hereinafter called the "invention," which is a continuation-in-part of pending prior application Serial No. 10/718,406, filed November 20, 2003.

Cooperation to the best of my ability in the execution of all lawful documents, the production of evidence, nullification, reissue, extension, or infringement proceedings involving said invention.
