# ASSIGNMENT

WHEREAS we, **Allen R. SUTTON**, a citizen of the United States, residing at State Route 145, Corydon, Kentucky 42406, and **Willis THORNSBERRY**, a citizen of the United States, residing at 1024 North Main Street, Sturgis, Kentucky 42459 (hereafter ASSIGNORS) have invented certain improvements in **ADDITIVE CONTAINING N-(n-butyl)THIOPHSPHORIC TRIAMIDE FOR UREA-BASED FERTILIZER**, an application for which is filed concurrently herewith, and for which we have filed a patent application with the U.S. Patent and Trademark Office for said invention on January 12, 2006, said application being assigned U.S. Patent Application No. 60/758,594.

AND ASSIGNORS DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue the said Letters Patent, when granted, to ASSIGNEE, its successors and assigns, as assignees of the entire right, title and interest in and to said improvements, for the sole use and benefit of said ASSIGNEE, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.




