## ASSIGNMENT

WHEREAS, I, Hans J. AND be it known that I authorize and empower the Assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any applications for patent or other form of protection for the Invention filed by it, the benefit of the right of priority

provided by the International Convention for Protection of Industrial Property, as amended, or by any Convention which may henceforth be substituted for it and to invoke and claim such right of priority without further written or oral authorization from me, and I hereby assign to the Assignee any and all right I may have to claim such priority in any country from a corresponding U.S. patent application relating to the Invention;

AND I hereby consent that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and particularly in proof of the right of the Assignee or nominee to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property as amended, or by any Convention which may henceforth be substituted for it;

AND I hereby covenant and agree to do all such things and to execute without further consideration such further lawful documents, assurances, applications and other instruments as may reasonably be required to obtain Letters Patent for the Invention and vest the same in the Assignee, its successors and assigns.
