TO THE SHERIFF OF TULSA COUNTY, OKLAHOMA:

WHEREAS, Stillwater National Bank and Trust Company ("SNB") recovered, *inter alia*, judgment against the Defendants herein, in the above-styled and numbered case in the District Court of Tulsa County, Oklahoma, to enforce a security interest upon certain personal property situated in Tulsa County, Oklahoma, which is more particularly described in Exhibit "A," attached as a part hereof (the "Property"). This Court has ordered that said security interest be foreclosed and that the Property be sold and the proceeds from the sale distributed to satisfy a judgment in favor of

SNB obtained in this Court, in the following amount: \$236,650.69, together with interest accrued through November 14, 2005 in the amount of \$3,031.07, late fees in the amount of \$7,672.47, interest accruing on the unpaid principal after November 14, 2005 at the rate of \$64.81 per day until paid, costs and attorneys fees on certain of the foregoing.

WHEREAS, said judgment remains wholly unpaid, and there has been no redemption thereof, and SNB has demanded a writ of execution to issue in accordance with the order of the Court.

NOW, THEREFORE, these are to command that you forthwith proceed to levy upon, advertise and sell the Property, and, in accordance with said Order of the Court, distribution of the proceeds of the sale be made. You will make due return of this Writ with your proceedings endorsed thereon, within sixty (60) days from this date.
