ASSIGNMENT

For good and valuable consideration, the receipt of which is hereby acknowledged, WE, **Li YAO**, a citizen of P.R. China and **Xuguang CI**, a citizen of P.R. Convention; and ASSIGNORS hereby authorize and request any officials of foreign countries whose duty it is to issue patents or any legal equivalent thereof, to issue said patents to ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said applications, said invention and said patents and legal equivalents as may be known and accessible to ASSIGNORS and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said applications, said invention and said patents and said equivalents in any country, which may be necessary or desirable to carry out the purposes thereof.
