ASSIGNMENT

WHEREAS, WE, ROSALYN S. WILTON, a citizen of Great Britain, residing at WEST HOUSE, CROCKHAM HILL, KENT, ENGLAND, TN8 6RG, and DAVID L. SILVERMAN, a citizen of the United States, residing at 16 Carman Lane, Saint James, New York 11780, have invented certain new and useful improvements in ELECTRONIC TRADING SYSTEM INCLUDING AN AUTO-ARBITRAGE FEATURE OR NAME SWITCHING FEATURE for which an application for Letters Patent of the United States was filed on December 12, 1995, and accorded Serial No. 08/571,106; and

AND WE HEREBY authorize and request the Commissioner of Patents and Trademarks or any other proper officer or agency of any country to issue all said Letters Patent to said assignee;

AND WE HEREBY warrant and covenant that we have full right to convey the entire interest herein assigned and that we have not executed and will not execute any instrument or assignment in conflict herewith;

AND WE HEREBY agree to communicate to said assignee or its representatives any facts known to us respecting said invention, to execute all divisional, continuation, reissue and foreign applications, sign all lawful documents and make all rightful oaths relating to said invention, and to testify in any judicial or administrative proceeding and generally do everything possible to aid the said

assignee to obtain and enforce said Letters Patent in the United States or any foreign country when requested so to do by said assignee.
