RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (this "*Release*") is dated as of January __, 2007 and made by Citicorp Trustee Company Limited, as security agent (the "*Security Agent*") as hereinafter described.

WITNESSETH:

WHEREAS, Citicorp Trustee Company Limited, as Security Agent, and, inter alios, Gambro, Inc. (the "*Grantor*") are parties to a certain Security Agreement dated as of November 17, 2006 (the "*Security Agreement*") pursuant to which the Grantor granted a security interest in, inter alia, the patents listed on Schedule A attached hereto (collectively, the "*Patents*");

WHEREAS, the Grantor will assign and transfer the Patents to Gambro Renal Products, Inc., and in connection therewith, such entity will grant a security interest to the Security Agent in such Patents;

WHEREAS, the Grantor has requested that the Security Agent release its security interests in the Patents;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Security Agent hereby, on the instructions of the Agent (as defined in the Security Agreement) in accordance with Clause 27.7 of the Intercreditor Agreement (as defined in the Security Agreement), releases its security interests, without any representation, warranty, recourse or undertaking by the Security Agent, and all of its right, title and interest, if any, in and to:

(i) Each Patent, together with all reissues, divisions, continuations, continuations-in-part, extensions and re-examinations thereof, all inventions therein, all rights therein provided by international treaties or conventions and all improvements thereto, and all other rights of any kind whatsoever accruing thereunder or pertaining thereto; and

(ii) All proceeds of the foregoing, including without limitation any claims for damages for past, present or future infringement, misappropriation or breach with respect to the foregoing in each case together with the right to sue for and collect, or otherwise recover, such damages.

Nothing in this Release shall prejudice or affect the security of the Security Agent under the Security Agreement in respect of the remaining property and assets charged therein or the rights of the Security Agent thereunder.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
