**ASSIGNMENT**

WHEREAS, Yoshinori Kakuno, Shiro Iida, and Yasushige Tomiyoshi, hereinafter called the "Assignors," have made the invention described in the United States patent application entitled HOLDER FOR FLUORESCENT LAMP, executed by Assignors on the same date as this Assignment;

Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
