This Assignment shall be binding on the heirs, assigns, representatives, and successors of the undersigned, and shall extend to the successors, assigns, and nominees of the Assignee.

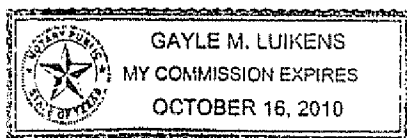

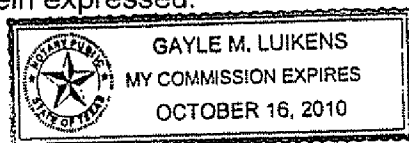
