PATENT ASSIGNMENT

This PATENT ASSIGNMENT (this "Assignment"), effective the 15th day of December, 2006, is made and entered into by and between LEAR CORPORATION, a Delaware corporation whose full post office address is 21557 Telegraph Road, Southfield, Michigan 48033, United States of America ("Assignor"), and INTERNATIONAL AUTOMOTIVE COMPONENTS GROUP, LLC, a Delaware Limited Liability Company whose full post office address is c/o WL Ross & Co., LLC, 600 Lexington Avenue, 19th Floor, New York, New York 10022, United States of America ("Assignee") (each a "Party," and collectively, the "Parties").

WHEREAS, Assignor has an ownership interest in the Letters Patent, Patent Applications, and/or Utility Models listed in the attached Addendum (the "Patents");

AND WHEREAS, Assignor and Assignee entered into that certain Sale and Purchase Agreement dated as of July 20, 2006 (the "Purchase Agreement"), pursuant to which Assignee and Assignor entered into an Intellectual Property License Agreement dated October 16, 2006 (the "IP License Agreement");

AND WHEREAS, pursuant to the IP License Agreement, the Assignee has the right to request Assignor to assign to the Assignee the Assignor's right, title and interest in and to the Patents which Assignor has decided not to continue to prosecute or maintain;

AND WHEREAS, Assignee desires to acquire the Assignor's right, title and interest in and to the Patents listed in the attached Addendum.

NOW, THEREFORE, for the consideration set forth in the Purchase Agreement, and for other good and valuable consideration, the receipt of which is hereby acknowledged, the Parties agree as follows:

1. Assignment. Subject only to the license retained by Assignor pursuant to Section 6.1 of the IP License Agreement, Assignor hereby sells and assigns to Assignee all of Assignor's right, title and interest in and to the Patents listed in the attached Addendum, to be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by Assignor had this assignment and sale not been made, including all rights therein provided by international conventions and treaties, and the right to sue for past infringements.

2. No Warranties. Except as expressly provided in the IP License Agreement, Assignor makes no warranties, express or implied, with respect to the Patents listed in the attached Addendum.

3. Further Assurances. Assignor shall, at the cost and expense of Assignee, timely execute and deliver any additional documents and perform such additional acts necessary or desirable to record and perfect the interest of Assignee in and to the Patents listed in the attached Addendum, and shall not enter into any agreement in conflict with this Assignment.

4. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York, regardless of the laws that might govern under principles of conflict of laws thereof.

5. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement.

IN WITNESS WHEREOF, the Parties have caused this Assignment to be executed by their duly authorized representatives.
