AND the Director of the United States Patent and Trademark Office is hereby authorized and requested to issue Letters Patent to the said Assignee in accordance with the terms of this agreement.

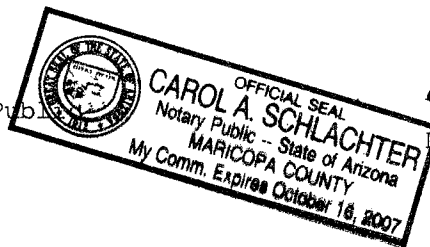
