PATENT ASSIGNMENT AGREEMENT

THIS PATENT ASSIGNMENT AGREEMENT made by SUNDANCE SPAS, INC., d/b/a Sundance Spas, a California corporation, having a place of business at 13951 Monte Vista Avenue, Chino, California 91710 ("Sundance"), to BALBOA INSTRUMENTS, INC., a California corporation, having a place of business at 1690 Scenic Drive, Costa Mesa, California 92626 ("Balboa").

WHEREAS, Sundance has entered into the Assignment and License Agreement dated SEP 29, 1998, pursuant to which Sundance has agreed to assign its patent rights to Balboa; and

WHEREAS, as part of the Assignment and License Agreement, Sundance has agreed to assign to Balboa certain patent rights.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises herein contained, the parties agree as follows:

1. SUNDANCE PATENTS. "Sundance Patents" shall mean the patents and patent applications listed on Schedule A, as well as any divisions, continuations, continuation-in-part, or reissue applications thereof, including without limitation, any foreign counterparts thereof.
2. ASSIGNMENT. Sundance assigns, transfers, and conveys to Balboa all of Sundance's rights, title, and interest throughout the world in and to the Sundance

Patents, the underlying inventions described therein, and all rights, claims, and privileges pertaining to the Sundance Patents.

Sundance authorizes and requests the Commissioner of Patents and Trademarks of the United States and of all foreign countries to issue any letters patent granted for said inventions, whether on patent applications or on any subsequently filed division, continuation, continuation-in-part, or reissue applications, to Balboa, its successors, and assigns, as the assignee of the entire interest in said inventions.

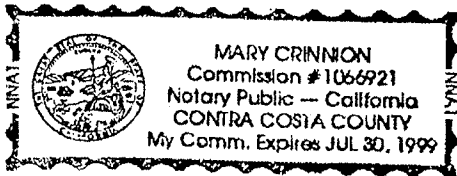

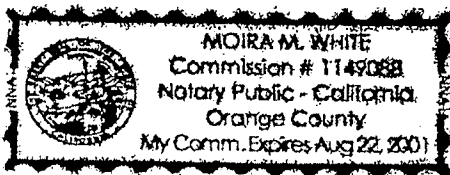
